# NVCC CERTIFIED NURSE AIDE TUITION INSTALLMENT PAYMENT PLAN AGREEMENT

A tuition installment payment plan is available to students enrolling in the CNA Program in the Fall 2009 Semester. It allows students to defer the payment of tuition for a **non-refundable fee of \$25.00**. This fee, along with the first payment of the course tuition, must be paid at the time of registration. Students wishing to use the tuition installment payment plan must complete this agreement. Students failing to make timely payments will not receive course verification, clinical evaluation or the CNA Certificate. **A late payment fee of \$15.00 will be charged for all payments received after the published due dates.** Unpaid amounts will be referred to collection. *Note: Completion of this agreement fully obligates students to fulfill the payment agreement. The \$25 non-refundable plan fee will be charged to each student, each semester. No payment reminders will be sent to you, so please keep your "Student's Copy" for reference. All installment payments must be made to the Cashiers Office.*
