By completing and returning the form with the attachments, the College will be able to issue a Certificate of Eligibility Form 1-20 required when applying for an F-1 student visa. The student will also need to show the Certification of Finances and attached proof of financial support at the American Embassy or Consulate when applying for the visa.
